I have prepared a flyer for you on Royal Caribbean's Explorer of the Seas at the prices quoted in my proposal to you of October 11<sup>th</sup>. I was able to hold the following number of cabins with the cruise line:

Inside Category N	@ \$638	11 held
Outside Category H	@ \$798	8 held
Balcony Category E1	@ \$889	11 held

They have a limited number of standard outside cabins on this ship, located on the bottom two decks (the H's we're holding are on the higher of these two decks); therefore, we are unable to secure more outside space at this price. Remember, for every cabin I hold, Pleasure Travel will be depositing with the cruise line \$50 so we can "sit on this space".

You must be aware that, even though the second deposit of \$250.00 is not due until June, the cruise line has the right to rescind any unsold space at any time they want. Unsold space to them is any cabin that does not have the full deposit of \$300.00 per person. This happens when a sailing date is close to selling out and they want to put the space we are holding back into their general inventory to be sold at higher prices. I will apprise you of that situation if I'm contacted by inventory control at any time prior to that June 1<sup>st</sup> date.

Deposits will be fully refundable (except for \$25 processing fee) up until final payment on July 15<sup>th</sup>. After that, cruise line penalties go into effect: If cancelled July 16<sup>th</sup> to 30 days prior - \$300 penalty; if cancelled 29 to 15 days prior - 50% penalty; if cancelled within 7 days - no refund. I, of course, will review this with everyone individually as they book. The insurance of \$59 allows you to cancel (for health reasons) and get a full refund no matter what date you have to cancel.

With a minimum of 30 passengers, Pleasure Travel will provide roundtrip bus transportation from the Elks' Lodge to Port of Miami. For every 16 passengers (1<sup>st</sup> & 2<sup>nd</sup> passengers only), we get a credit of 1 "free" passage (excluding taxes of \$168.10). This credit can be distributed however you instruct me.

I can adjust the flyer however you want and can print additional at any time. I, of course, will review all of the above and answer all questions when I meet with you on Thursday evening, November 11<sup>th</sup>. I will be out of town October 23 to November 1<sup>st</sup> and just wanted you to have a supply of these flyers while I was gone. Please do not hesitate to call me at any time with any questions. I'm very much looking forward to handling a group for the Hollywood West Elks again.
